## **Why Should My District Consider Joining MARE**

### **Resolution for Blue Ribbon Commission - Formula**

A growing number of school districts around the state are taking action through their local BOE to pass a resolution calling on the State BOE to appoint a Blue Ribbon Commission to study the Funding Formula for education in Missouri. This approach is being pursued as all of us are aware that the foundation formula is broken and in dire need of being addressed. Rather than have conversations about legal remedies, the focus is on calling on the State BOE to help with this matter. Pasted below is a sample BOE Resolution that you can share with your BOE and ask them to approve it at an upcoming meeting. The targeted date for approval of these resolutions is no later than November 2023. #### **Resolution Calling for the Appointment of a Blue Ribbon Commission to Study Missouri's Funding Formula**

Whereas, Missouri funds school districts through a basic foundation formulation, and;  
Whereas, Missouri funds school districts through a basic foundation formulation created in 2005 with the passage of Senate Bill 287, and;  
Whereas, the State Adequacy Target (SAT) is a driver of foundation formula funding for Missouri schools, and;  
Whereas, the SAT has been \$6,375 since FY20 and will remain so through FY24, and;  
Whereas, the \_\_\_\_\_ School District is \_\_\_\_\_% funded by the state of Missouri, and;  
Whereas, Missouri funds elementary and secondary education from local sources at a significantly higher level than the national average\*, and;  
Whereas, the SAT has remained relatively level over the past decade in current dollars, but has declined when adjusted for inflation\*, and;  
Whereas, the Missouri Legislature has altered the foundation formula for it to be considered "fully funded", and;  
Whereas, in 2020, Missouri was ranked 49th in the nation in the percentage of school funding coming from state resources (32 percent), according to NEA data\*, and;  
Whereas, since the reinstatement of the 5 percent growth cap on the SAT in 2016, the SAT has not kept up with inflation\*, and;  
Whereas, the SAT has steadily decreased over the last 10 years when adjusted for inflation\*, and;  
Whereas, the \_\_\_\_\_ School District has averaged less than \_\_\_\_\_% growth in state funding over the past 6 years which is lower than the Consumer Price Index (inflation rate)

in each of those years,  
NOW, THEREFORE, BE IT RESOLVED BY THE \_\_\_\_\_ BOARD OF  
EDUCATION, as follows:

SECTION 1. That the Board of Education hereby calls upon the State Board of  
Education to appoint a Blue Ribbon Commission to study the foundation formula and pre-  
sent findings and recommendations no later than November 30, 2023.

SECTION 2. That this resolution shall be in full force and effect from and after the date  
of its passage and adoption, and approved by the Board of Education.

**E-Impacts School Project Opportunity - Grant**

**Overview of E-IMPACTS Project**

*E-IMPACTS refers to Evidence-Informed Mental health Prevention, Assessment, Collaboration, & Treatment in Middle Schools. It is a partnership among the University of Virginia, University of Missouri, and University of South Carolina.*

**What is E-IMPACTS?**

The E-IMPACTS project will evaluate different approaches for supporting the use of a mental and behavioral health screening system, called the **Early Intervention System (EIS)**. E-IMPACTS is recruiting middle schools that 1) have elected to use EIS to implement universal mental and behavioral health screening procedures and 2) are open to receiving additional professional learning support to support effective use of the EIS.

Specifically, we have received funding from the National Institute of Health to offer schools **support in using the EIS** and to test the use of an evidence-supported, **online professional learning** model to facilitate effective screening/interventions procedures.

- The online **EIS** tool allows schools to screen students for mental or behavioral health needs and provides recommendations for evidence-based interventions and supports.
- The **Extension for Community Healthcare Outcomes (ECHO)** model connects school staff with each other and university researchers to collaboratively problem solve challenges they may be experiencing related to supporting student mental and behavioral health needs.

**Short- and Long-Term Project Goals:**

- •Improve schools' ability to use screening procedures to inform the use of effectivemental health practices
- •Improve educators' ability to support student mental health
- •Improve student mental and behavioral health functioning
- •Reduce student disruptive behaviors and improve academic outcomes
- •Improve teacher efficacy, impact, and retention

**Middle schools** (typically grades 6-8) located in **Virginia, South Carolina, or**

**Missouri.** Middle schools should be:

1. Located in **rural** or **small communities**, have **interest in using a screening tool to identify students with mental or behavioral health needs**, and

2. **Have a team** (4-5 staff) **of teachers, mental health staff** (e.g., counselors, psychologists) **and administrators** who **meet to discuss student mental and behavioral health needs** (e.g., student support team, problem-solving team, MTSS team).
