Foundation Formula Modernization Task Force — The School Modernization Task Force is now conducting Working Group meetings until early December. The meetings will be livestreamed. It is vitally important that school leaders, BOE members, community patrons and those who support public schools tune in to these meetings or listen to the recordings to stay informed. Open Enrollment Appeal – Open Enrollment was held at bay again this past session. We are thankful for all of those districts who have passed a BOE Resolution in opposition to Open Enrollment. The list has grown (attached) and now sits at 259 school districts opposed, impacting 454,600 student lives in Missouri. The list has been noticed by various legislators and it has had an impact! We are appealing to the other 257 or so public-school districts to take action and pass the attached resolution in opposition. Our hope is that if the number continues to grow, legislators will have to seriously consider the issue before casting a vote when the issue comes up again in the 2026 session. Thanks to Dr. Chris Gaines at EdPlus, Dr. Kenny Southwick with CSDGKC, and Dr. Pam Hedgpeth with GOCSD for their efforts in spreading the word. Thanks also to our meany educational associations for their support in this endeavor and for sharing information with their respective memberships. 
